QUITCLAIM PATENT ASSIGNMENT

WHEREAS, Multidrain makes no representations or warranties concerning any right, title or interest in or to said Patent and specifically disclaims any such right, title or interest;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns unto Assignee all of Assignor's right, title, and interest, if any, which Assignor has or may have in and to:

- (i) the Patent;
- (ii) any and all provisional, continuation, continuation-in-part, divisional, substitute, renewal, reissue, and reexamination patents or patent applications arising from the Patent; and
- (iii) any other invention, improvement, technique, or discovery that has been developed, discovered, or invented based on the Intellectual Property, as defined in the Mutual Release, or developed, discovered, or invented to circumvent any of the patents constituting the Intellectual Property, as defined in the Mutual Release;

the same to be held and enjoyed by Assignee, for its own use and enjoyment, and for the use and enjoyment of its successors, assigns, or other legal representatives, to the end of the term or terms for which the Patent is granted or exists, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment had not been made. This Assignment includes the right, if any such right remains, to file additional applications related to the Patent and the assigned inventions under any convention or treaty and to claim priority in such applications based upon the Patent.

Assignor authorizes and requests the United States Patent and Trademark Office and comparable government authorities in other countries to transfer the Patent by assignment to Assignee and to issue to Assignee any other patents hereafter granted on the Patent and the assigned inventions described herein.

Assignor covenants that no assignment, sale or encumbrance has been or will be made or entered into which would conflict with this assignment.

Assignor hereby assigns unto Assignee any cause of action it may have against any of its current or former employees who is or who claims to be the inventor of the Patent and the assigned inventions, and agrees to promptly provide to Assignee the inventor assignments for the Patent, if any, and the assigned inventions to the extent in Assignor's possession or control, and, upon Assignee's request, copies or originals of Assignor's Patent files, if any. Assignor agrees to execute and deliver all other papers, instruments, and assignments and perform other reasonable acts when and as reasonably requested by Assignee to vest in Assignee all of Assignor's right, title and interest, if any, in and to the Patent and the assigned inventions. Assignor agrees to provide, at Assignee's expense, additional evidence to support the foregoing if such evidence is considered necessary by Assignee, is in Assignor's possession or control, and is reasonably available and retrievable.
