
ASSIGNMENT

We further authorize said company to apply for foreign patents on said invention in its own name or through its designees, including subsidiaries, related companies or assignees, under the International Convention or otherwise, and we further agree to execute all papers, including those required for the United States and foreign applications, and to perform such other proper acts as said company may deem necessary to secure to said company or its designees the rights herein assigned.


