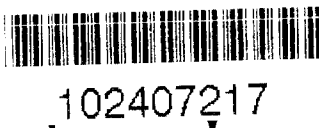



ASSIGNMENT


WHEREAS, I, **LEROY L. NOW THEREFORE, for good and valuable consideration, I do hereby sell, assign, transfer and set over unto **ASSIGNEE**, their legal representatives, successors and assigns, the entire right, title and interest in and to the invention as set forth in the above mentioned application, and in and to all patents of the United States and in any and all foreign countries which may be issued for the invention, and in and to all patent applications, continuations, continuation-in-part, divisionals, reexaminations and reissues of said invention as described in the above-mentioned application in the United States and in any and all foreign countries, as fully and completely as the same would have been held by me had this assignment and sale not been made together with all claims for damages by reason of past infringement with the right to sue for and collect the same and obtain all other possible remedies for its own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives. The entire right, title and interest shall vest irrevocably in **ASSIGNEE**. I further agree upon request, without additional compensation, but at no expense to myself, to execute or assent to foreign applications, and to execute all other legal documents as may be necessary or desirable to vest the enjoyment of the said entire right, title and interest rights hereby transferred in **ASSIGNEE**, their legal representatives, successors and assigns, or as they may direct.

I further request the Commissioner of Patents and Trademarks to issue any Letters Patent of the United States which may be issued for the invention to **ASSIGNEE**, their legal representatives, successors and assigns, as the sole owner of the entire right, title and interest in and to the patents and inventions covered thereby.
