

ASSIGNMENT

WHEREAS, WE, JENS P. TAGORE-BRAGE, KAI HARREKILDE-PETERSEN, CLAUD P. JENSEN, AND JØRGEN RAVN HANSEN, residing at Edvard Glæsels Vej 3, DK-2000 Frederiksberg, Denmark; Docentgatan 1B, 215 52 Malmö, Sweden; Viborggade 82B, 5.tv., DK-2100 Kbh. Ø., Denmark; and Holsteinsgade 61, 2.th., DK-2100 København Ø, Denmark, respectively, have invented certain new and useful improvements disclosed in an application for United States Letters Patent entitled **PACKET FORWARDING METHOD AND SYSTEM**, filed May 2, 2003, Application No. 10/429,267.

AND WE HEREBY further covenant and agree that we will communicate to ASSIGNEE any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said improvements in all countries.
