ASSIGNMENT OF INVENTION

WHEREAS, I, ROBERT A. WOLFF, residing at 8 Calvin Drive, Selingsgrove, PA 17870 have made a certain new and useful invention in an ORGANIZING SYSTEM FOR DRAWERS AND CABINETS and have executed an application for Letters Patent of the United States based thereon on even date herewith.

association with the said WOOD-MODE INCORPORATED, and for one year thereafter, in and to said application for Letters Patent and any and all Letters Patent and extensions thereof, of the United States and countries foreign thereto which have been or may be granted on said invention or any part thereof, or improvements thereon or on said application, or any divisional, continuing, renewal, reissue, or other application and all international priority rights associated therewith, based in whole or in part thereon, or based upon said invention, or any improvements thereon;

TO BE HELD AND ENJOYED by the said WOOD-MODE INCORPORATED, and its legal representatives and assigns to the full ends of the terms for which said Letters Patent, or any of them, have granted as fully and entirely as the same would have been held and enjoyed by me had no sale and assignment of said interest been made; and I do hereby authorize and request the Commissioner of Patents and Trademarks to issue any and all Letters Patent which may be granted upon the said application above referred to, or any of them, or upon said invention or any part thereof, or upon any improvements thereon which may be made, conceived or acquired by me during the course of my association with the same company and for one year thereafter, to WOOD-MODE INCORPORATED, aforesaid, and I hereby agree for myself, my heirs, executors and administrators, to execute without further consideration, any further legal documents and any further assignments and any releases, reissues, renewals or other application for Letters Patent that may be deemed necessary by WOOD-MODE INCORPORATED, herein named, fully to secure to WOOD-MODE INCORPORATED, its interest as aforesaid in and to said invention or any part thereof or any improvements thereon, and in and to said several Letters Patent, or any of them.

I do hereby covenant for myself and my legal representatives, and agree with WOOD-MODE INCORPORATED, and its legal representatives, that I have granted no license to make or sell the said invention, that prior to the execution of this deed my right, title and interest in the said invention has not been encumbered, that I then had good right and title in and to the invention and that I have not executed and will not execute any instrument in conflict therewith.
