ASSIGNMENT

WHEREAS, we, Steven Wesley Templeman of Joplin, Missouri, and Scott Wesley Templeman of Carthage, Missouri, all United States citizens, have invented a certain new and useful improvement in AUTOMATIC HOOK SETTING, FISHING ROD HOLDER, for which United States Patent Application Serial No. 10/307,901 was filed December 2, 2002, preparatory to obtaining United States Letters Patent therefor; and

proceedings, sign all lawful papers, execute all division, continuation, substitution, renewal, reissue and reexamination applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said Mid-Western Outdoor Specialties, LLC, make all rightful oaths and generally do everything necessary or desirable to aid said Mid-Western Outdoor Specialties, LLC, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.


