ASSIGNMENT

WHEREAS, WE, OLGA K. PENROD, a citizen of the United States, residing at 4973 Boyce Road, Seaford, DE 19973; TOMMY M. WICKLINE, a citizen of the United States, residing at 11132 Ocean Gateway, Easton, MD 21601; and LYNN IRWIN, a citizen of Canada, residing at 27 River's End Drive, Seaford, Delaware 19973; hereinafter referred to as ASSIGNORS, have invented certain new and useful improvements in Design for PLATE for which WE filed an application for Letters Patents on January 10, 2003 as Application Serial No. 29/174,105;

WHEREAS, MARYLAND PLASTICS, INC., a corporation organized and existing under the laws of the State of Maryland, having a mailing address at P.O. Box 472, 251 East Central Avenue, Federalsburg, MD 21632, hereinafter referred to as ASSIGNEE, is desirous of obtaining the entire right, title and interest in, to and under the improvements and the application;

AND WE HEREBY covenant that WE have full right to convey the entire interest herein assigned, and that WE have not executed, and will not execute, any agreement in conflict herewith.

AND WE HEREBY further covenant and agree that WE will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to us respecting the improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and

generally do everything possible to aid the ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for the improvements in all countries.
