I do hereby authorize and request the Commissioner of Patents and Trademarks to issue United States patents on said invention to Assignee.

**I DO HEREBY COVENANT** and agree with Assignee that I will not execute any writing or do any act whatsoever conflicting with the terms of this assignment document set forth herein, and that I will at any time upon request, without further or additional consideration, but at the expense of the Assignee, execute such additional assignments and other writings and do such additional acts as the Assignee may deem necessary or desirable to perfect the Assignee's enjoyment of this assignment, and render all necessary assistance in making application for and obtaining patents of the United States and of any and all foreign countries on the invention, including, but not limited to, provisional applications, non-provisional applications, continuations, continuations-in-part, divisionals, reissues, renewals, and extensions, and in enforcing any rights or choses in action

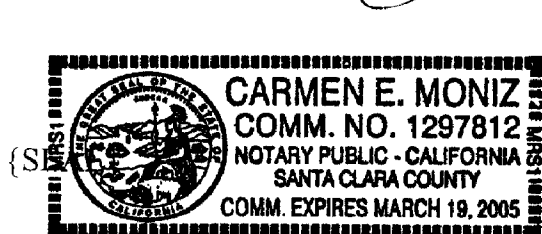
