AND I HEREBY authorize and request the Commissioner of Patents and Trademarks to issue all such Letters Patent to the said DESTINY PLASTICS, INC. in accordance with this instrument of Assignment.

I FURTHER covenant and agree, in consideration of the premises, that I or my executors and administrators, will execute and deliver to the said DESTINY PLASTICS, INC., its successors and

assigns, any further documents or instruments, and do any and all further acts that may be deemed necessary by the said DESTINY PLASTICS, INC., its successors and assigns, to file applications for the said improvements and invention in any country where it may elect to file such applications, and that may be necessary to vest in the said DESTINY PLASTICS, INC., its successors and assigns the title herein conveyed or intended so to be, and to enable such title to be recorded in the United States and foreign countries where such application or applications may be filed.

AND I FURTHER covenant and agree, in consideration of the premises, that I or my executors and administrators, will at any time upon request communicate to the said DESTINY PLASTICS, INC., its successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to us or to our executors and administrators, and that I will testify as to the same in any interference or other litigation when requested so to do by the said DESTINY PLASTICS, INC., it being understood that DESTINY PLASTICS, INC. will compensate me for my expenses reasonably incurred in complying with its requests.
