WHEREAS, Masaaki YAMAMOTO, Yoshiaki HIRAMATSU, Tatsuaki WAKABAYASHI, and Hiroshi KANTO hereinafter called the "Assignors", have made the invention described in the United States patent application entitled, Methods and Devices for Carrying out User Authentication, executed by Assignors on the same date as this Assignment;
