## ASSIGNMENT

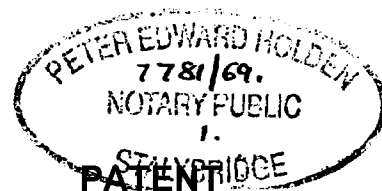

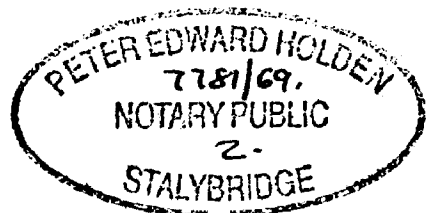


