**ASSIGNMENT AND AGREEMENT**

**WHEREAS, Brian J. Siehr** of W1863 Revere Court, Sheboygan, Wisconsin 53083 and **Cory R. Boudreau** of 4309 Odana Road, Madison, Wisconsin 53711; (hereinafter referred to singly and collectively as "ASSIGNOR") have invented a certain invention entitled **UTENSIL BOWL** (Atty. Dkt.
