**WHEREAS**, I, DANNY SPIRTUS, a citizen of Israel, having an address at 3 Maalot St., Holon, Israel (ASSIGNOR), have invented certain new and useful improvements in an **MULTI-FEED REFLECTOR ANTENNA** for which a U. S. application for Letters Patent of the United States Patent was filed on April 6, 2001, and accorded Application No. 09/827,370; and

**NOW THEREFORE**, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR, by these presents does sell, assign, and transfer unto GILAT and SPACENET, its successors, legal representatives, and assigns, the full and exclusive right in and to the invention as described in the said application, and the entire right, title, and interest in and to any and all Letters Patents which may be granted therefor in the United States and its territorial possessions, and in any and all foreign countries, and in and to any and all utilities, divisions, continuations, continuations-in-part, substitutions, renewals, reexaminations, reissues, and extensions thereof;

**ASSIGNOR** hereby warrants and covenant that he has the full right to convey the entire right, title, and interest herein assigned and that no other instrument or assignment has been or will be executed in conflict with this Assignment.

**ASSIGNOR** hereby authorizes and requests the Assistant Commissioner for Patents or any other proper officer or agency of any country to issue all said Letters Patent to said GILAT and SPACENET as assignees.

**ASSIGNOR** further agrees to communicate to GILAT and SPACENET or its representatives any facts known to **ASSIGNOR** respecting said invention, and to testify in any judicial or administrative proceeding, to sign all lawful papers, to execute all utility, divisional, continuation, continuation-in-part, substitution, renewal, reexamination, reissue applications, and extensions thereof, to execute all assignment papers to cause all of said Letters Patent to be issued to GILAT and SPACENET to make all rightful oaths and generally do everything possible to aid GILAT and SPACENET, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and its territorial possessions, and in any and all foreign countries.


