which is set forth in an application for Letters Patent filed on December 19, 2002 in the United States having Serial No.10/324,580, and Attorney Docket No. 61,733-113.



enjoyed by the Assignee, as fully and entirely as the same would have been held by the Assignors had this Assignment and sale not been made.




