ASSIGNMENT

WHEREAS, I, John K. Blomstrom of Sheboygan Falls, Wisconsin, have made certain inventions which are described in an application for Letters Patent of the United States entitled FACE PLATE FOR PLUMBING FIXTURE (a/k/a Forte Finial Showerhead Face Plate) filed January 20, 2003 as U.S. Serial No. 29/174,563 preparatory to obtaining United States Letters Patent therefor; and




