WHEREAS, Christophe Lacroix, residing at Hameau Les Verrières, 27700 Harquency, France, a citizen of France, hereinafter referred to as ASSIGNOR, has invented and owns a certain invention entitled:

required to apply for, obtain, maintain and enforce said applications, said invention and said Letters Patent which may be necessary or desirable to carry out the purposes hereof.
