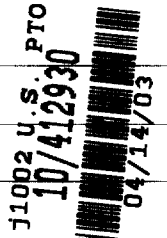


WHEREAS, I, PAUL W. GUTH, have invented certain new and useful improvements in
