

ASSIGNMENT

Box 50310, SE-202 13 Malmo, Sweden, is the owner by previous assignment, dated September 17, 2001, as recorded under Reel/Frame 012303/0443 on November 13, 2001, of the entire undivided right, title and interest of Hans GRONWALL, in and to an invention for new and useful improvements in or relating to STICK PACKAGE for which an application for Letters Patent in the United States was executed on September 17, 2001 and assigned Application Number 29/147,294, and is the owner of an undivided right, title and interest in and to said application by said previous assignment;

WHEREAS, JAGOTEC AG, a corporation organized and existing under and by virtue of the laws of Switzerland, having an office at Eptingerstrasse 51, CH-4132 Muttenz, Switzerland, is desirous of acquiring the entire right, title and interest in and to the said application and the invention therein described and claimed and any Letters Patent that may be issued upon said application or for the improvements therein contained;

NOW THEREFORE, for and in consideration of the sum of Ten Dollars (\$10.00) lawful money of the United States and other valuable considerations, to me in hand paid, the receipt of and sufficiency whereof are hereby acknowledged, the said BIOGLAN AB, has sold, assigned and transferred and does hereby sell, assign and transfer unto the said JAGOTEC AG, its successors and assigns, its entire undivided right, title and interest in and to the said application and the invention therein contained, including all rights of action and damages for past infringement, and including the right to apply for any Letters Patent in the United States of America and in all foreign countries on said invention and including the right to claim the priority of the date of filing in the United States and any Letters Patent that may issue thereon, or therefor, in the United States and foreign countries and all reissues, extensions, renewals, divisions and continuations thereof, to the full end of the term or terms for which said Letters Patent may be issued, to be held and enjoyed by the said JAGOTEC AG, its successors and assigns the same as it would have been held and enjoyed by BIOGLAN AB, if this assignment and sale had not been made.

AND, BIOGLAN AB, hereby authorizes and requests the Commissioner of Patents and Trademarks to issue all such Letters Patents to the said JAGOTEC AG, in accordance with this instrument of assignment.

BIOGLAN AB, hereby represents and warrants that there are no


rights or interests outstanding inconsistent with the rights and interests granted herein and that BIOGLAN AB, will not execute any instrument or grant or transfer any rights or interests inconsistent therewith, and BIOGLAN AB, binds itself and its heirs, executors, administrators, employees and legal representatives, as the case may be, to execute and deliver to the said JAGOTEC AG, its successors and assigns, any further documents or instruments and do any and all further acts that may be deemed necessary by the said JAGOTEC AG, its successors and assigns to file applications for the said improvements and invention in any country where it may elect to file such applications, and that may be necessary to vest in the said JAGOTEC AG, its successors and assigns, the title herein conveyed, or intended so to be, and to enable such title to be recorded in the United States and foreign countries where such application or applications may be filed.

AND, BIOGLAN AB, further covenants and agrees, in consideration of the premises, that it, its executors and administrators will, at any time upon request, communicate to the said JAGOTEC AG, its successors and assigns, any facts relating to the said invention and improvements and the history thereof, known to it or its successors and assigns, and that it will testify as to the same in any interference or other proceeding when requested to do so by the said JAGOTEC AG, its successors and assigns.

The undersigned hereby grants the law firm of Birch, Stewart, Kolasch & Birch, LLP the power to insert on this Assignment any further identification which may be necessary or desirable in order to comply with the rules of the U.S. Patent and Trademark Office for recordation of this document.
