ASSIGNMENT FOR APPLICATION FOR PATENT

WHEREAS: Yongchi Tian whose address is 3 Heath Court, Princeton, NJ 08540, (hereinafter referred to as Assignor) has invented a certain invention entitled "METHOD OF COATING MICROMETER SIZED INORGANIC PARTICLES" for which an application for Letters Patent of the United States is being filed concurrently herewith, and executed on even date herewith:

2. Said Assignor hereby covenants and agrees to cooperate with said Assignee to enable said Assignee to enjoy to the

fullest extent the right, title and interest to said Invention herein conveyed in the United States, foreign countries and groups of countries. Such cooperation by said Assignor shall include prompt production of pertinent facts and documents, giving testimony, execution of petitions, oaths, specifications, declarations or other papers, and other assistance all to the extent deemed necessary or desirable by said Assignee for perfecting in said Assignee the right, title and interest herein conveyed; for prosecuting any of said applications; for filing applications covering said Invention; for filing and prosecuting applications for re-issuance of any of said Patents; for interference or other priority proceedings involving said Invention; and for legal proceedings involving said Invention and any application therefor and any Patents granted thereon, including without limitation opposition proceedings, cancellation proceedings, priority contests, public use proceedings, infringement actions and court actions; provided, however, that the expense incurred by said Assignor in providing such cooperation shall be paid for by said Assignee.

3. The term and covenants of this agreement shall inure to the benefit of said Assignee, its successors, assigns and other legal representatives, and shall be binding upon said Assignor, his/her respective heirs, legal representatives and Assigns.

4. Said Assignor hereby warrants and represents that he/she has not entered and will not enter into any assignments, contract, or understanding in conflict herewith and that he/she has the right to make this Agreement.
