ASSIGNOR authorizes and requests the Commissioner of Patents and Trademarks to issue any and all United States Letters Patent resulting from the inventions and Applications for United States Letters Patent listed hereinabove or any divisions, reissues, continuations (in whole or in part), renewals, extensions, substitutes or re-examinations thereof to ASSIGNEE as assignee of ASSIGNOR's interest therein.
