## **RE-ASSIGNMENT OF PATENT**

This re-assignment is made effective as of the date last set forth below from Priscilla B. Berry and Richard M. Burch (as heirs of Miller L. Burch) and Priscilla B. Berry and Richard M. Burch (as co-trustees of the trust created under the Will of Opal M. Burch, deceased), hereinafter the "Assignors" and Richard M. Burch, hereinafter "Assignee" and collectively the "Parties."

### **Recitals and Acknowledgments**

Pursuant to an Assignment of Patent dated December 21, 1989 recorded with the US Patent and Trademark Office at Reel/Frame no. 005232/0989 recorded 02/26/1990 (hereinafter the 1989 Assignment), Richard M. Burch, the inventor of an aggregate stabilizing emulsion (the "Emulsion") under patent No. 4,822,425 (hereinafter the Patent), Richard M. Burch assigned his entire interests in the Emulsion and Patent to Assignors.

Assignor Priscilla B. Berry acknowledges that she is the daughter of Miller L. Burch and that she and Richard Burch are the sole heirs of Miller L. Burch.

Assignor Richard M. Burch acknowledges that he is the son of Miller L. Burch and that he and Priscilla B. Berry are the sole heirs of Miller L. Burch.

Assignors acknowledge that all indebtedness and obligations evidenced by the Note have been satisfied IN FULL and that the conditions for Reassignment and Reacquisition by Richard M. Burch of the Patent pursuant to paragraphs 2 and 3 the 1989 Assignment have long ago been met.

NOW THEREFORE, for adequate consideration, the receipt and sufficiency is hereby acknowledged, the Assignors and Assignee, as evidenced by their signatures below, agree as follows:

### **Agreement**

1. Re-assignment. Pursuant to paragraph 2 and 3 of the 1989 Assignment, Assignors assign to Assignee all of their right title and interest in the Emulsion and the Patent to Assignee Richard M. Burch that Assignors acquired through the Assignment of Patent dated December 21, 1989.

2. Binding Effect. This Agreement is binding on the heirs, executors, administrators, legal representatives, successors and assigns of the respective Parties.

3. Further Documentation. The Parties will execute any further or additional instruments and perform any acts which may become necessary in order to effectuate and carry out the purposes of this Agreement.

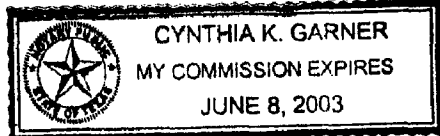
