

for said invention in all countries.

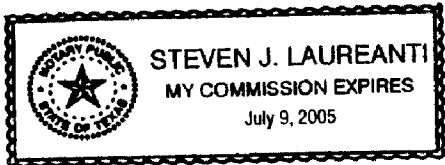



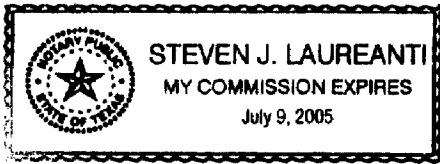
