

I hereby authorize and request the Commissioner of Patents and Trademarks to issue said Letters Patent and design patent or registration to said

GLOBAL TOTAL OFFICE, the assignee of our entire right, title and interest in and to the same, for its sole use and benefit, and for the use and benefit of its successors and assigns, to the full end of the term for which Letters Patent or design patent or registration may be granted, as fully and entirely as the same would have been held by me had this assignment and sale not been made.
