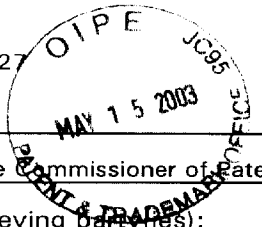

**ASSIGNMENT**

WHEREAS, Kenneth Schofield, Joshua L. DeWard, Peter J. Whitehead and Niall R. 


