ASSIGNMENT OF PATENT APPLICATION

WHEREAS, I, GEORGE DARAFEEV, citizen of THE UNITED STATES (hereinafter referred to as "ASSIGNOR"), have invented and own an ornamental design for a BUCKET FOR CHAIRS, BARSTOOLS, OR THE LIKE for which we will execute application papers for the United States Letters Patent thereon; and

ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said invention and said Letters Patent and legal equivalents as may be known and accessible to ASSIGNOR and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and

said equivalents in the United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.

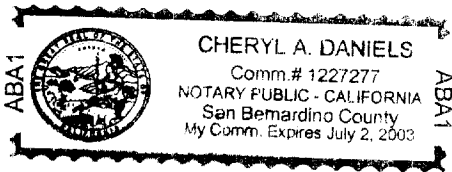


