ASSIGNMENT OF PATENT  
AND  
UNITED STATES REGISTRATION THEREOF

THIS AGREEMENT entered by and between JAMES SOUDER and JUDITH SOUDER ("SOUDER") on the one hand and NORFIELD'S CORPORATION ("NORFIELDS") on the other hand, is effective nunc pro tunc as of January 16, 2001.

WHEREAS, on January 16, 2001, JUDITH SOUDER assigned 50% of her entire rights and title in and to U. S. Patent No, 6,001,055 (the '055 patent), and orally assigned 50% of any patent improvements or applications relating to the '055 Patent or its application to NORFIELDS;

WHEREAS JUDITH SOUDER is the owner of U. S. Patent No. 6,231,497B1 (hereinafter the '497 patent) issued May 15, 2001, naming James Souder, inventor;

WHEREAS, JUDITH SOUDER desires to further formalize the above noted oral assignment and more specifically, assign 50% of all subsequent patent improvements and other patents resulting from the '055 patent, including without limitation, application number 442,156, which has matured into patent number 6,231,497B1 (hereinafter the '497 patent) to NORFIELDS;

WHEREAS, at the relevant time, JUDITH SOUDER owned all rights, title and interest to the subject matter now being assigned;

WHEREAS, NORFIELDS is desirous of acquiring ownership of the '497 patent and related rights, including the ability to sue infringers of the patent for damages and injunctive relief;


NOW, THEREFORE for good and valuable consideration, the receipt and sufficiency of which is expressly acknowledged,

SOUDER represents and warrants that the above recitals are true and correct, and are hereby incorporated by reference.



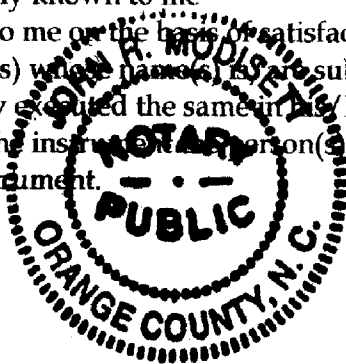


