

2. Releases

(a) Lender hereby agrees that, upon (i) receipt by Lender on this date of the Pay-Off Amount in immediately available funds in accordance with Section 1, confirmed in writing by Lender (which confirmation Lender hereby agrees to provide to Borrower by facsimile on the date of the receipt of the Pay-Off Amount) (the "Pay-Off Date"), (ii) receipt by Lender of an original (or facsimile) of this letter executed by each of the parties hereto and (iii) receipt by Lender of a copy of the final, but unexecuted, pages of the loan agreement and promissory note(s) evidencing the pricing terms of the indebtedness of Borrower to Wachovia Bank, National Association, then (c) Borrower will not be indebted to the Lender for any reason under the Loan Documents (other than with respect to the Continuing Obligations described in Section 2(h) below) and Lender's commitment to extend further credit to Borrower under the Loan Documents will terminate, (u) the Credit Agreement and all of Lender's security interests in, security titles to and other liens on the real and personal property of Borrower granted thereunder will be automatically terminated and released (except that the Continuing Obligations shall survive such termination), (v) all guarantors of the Obligations (other than with respect to the Continuing Obligations) will be automatically released from their obligations to Lender, (w) on the Pay-Off Date Lender will send to Borrower signed copies via facsimile (with originals to follow via overnight mail) of the two letters attached hereto as Exhibit A, (x) Lender will send to Borrower each of the Notes marked "PAID" within 10 days of the Pay-Off Date, (y) Lender will promptly execute any and all Uniform Commercial Code financing statement terminations, mortgage releases and other such lien release documents as Borrower or Wachovia Bank, National Association ("New Lender") may reasonably request in order to evidence or otherwise give public notice of such collateral terminations and releases, and (z) Borrower and New Lender are hereby authorized to file the financing statement terminations, mortgage releases and other lien release documents, in connection with the collateral terminations and releases mentioned above, in Lender's name, with or without the signature of Lender, provided, however, that any and all such termination statements, mortgage releases and other such documents shall be prepared and recorded at the Borrower's expense.


