

ASSIGNMENT OF PATENT RIGHTS


NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign, transfer and set over to NVIDIA, the Patents aforesaid, and any inventions claims in said Patents, any reissue or reissues of said Patents already granted and which may be granted, any certificates of reexamination already granted and which may be granted, the same to be held and enjoyed by NVIDIA for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, to the end of the term or terms for which said Patents are or may be granted, reissued or extended as fully and entirely as the same would have been held and enjoyed by Assignor, if this Assignment and sale had not been made; together with all claims for damages by reason of past infringement of said Patents, with the right to sue for, and collect the same for its own use and behalf, and for the use and behalf of its successors, assigns or other legal representatives.

Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any and all Letters Patent of the United States on said inventions to NVIDIA Corporation as Assignee of the entire interest, and hereby covenants that Assignor has the full right to convey the entire interest herein assigned, and that, except as otherwise provided for between the parties, Assignor has not executed, and will not execute, any agreement in conflict therewith.

Assignor hereby appoints Assignee its attorney-in-fact to act in Assignor's name, place and stead to execute, deliver and record any document or instrument of assignment required in any country in which any of the Patents are pending or issued, granting or confirming the rights granted herein, but only to the extent of those rights granted herein in connection with the Patents mentioned herein.
