Whereas, We, EBERHARD SCHNAIBEL of Hochstetterstrasse 1/5, 71282 Hemmingen, Federal Republic of Germany, KLAUS WINKLER of Schubertstrasse 34, 71277 Rutesheim, Federal Republic of Germany, and KLAUS HIRSCHMANN of Paracelsusstrasse 44, 71229 Leonberg, Federal Republic of Germany, have invented certain new and useful improvements in Method and Model for Modeling an Out-Storage Phase of a Nitrous Oxide Storage Catalytic Converter, the specification of which was filed as PCT international application number PCT/DE 01/02749 on July 20, 2001, and for which the Declaration for the application for United States Letters Patent has been executed on even date herewith, (said application having Attorney Docket No. R 39078; and,
