A S S I G N M E N T

WHEREAS, we, Ingo Gerber and Jan Tuma, are citizens of Germany respectively residing at Vogelsangstr. 25, 71093 Weil im Schönbuch, Germany and Marchwizastr. 48, 12681 Berlin, Germany (hereinafter ASSIGNORS), have made a certain invention entitled SELF-CLEANING DISPLAY DEVICE for which we are making application for Letters Patent of the United States, which application has been executed concurrently herewith; and

WHEREAS, Gottlieb Binder GmbH & Co, a corporation duly organized under the laws of Germany, located and doing business at Bahnhofstrasse 19, D-71088 Holzgerlingen, Germany (hereinafter ASSIGNEE), is desirous of acquiring the entire right, title and interest in and to the aforementioned invention and the aforementioned application and any and all Letters Patent to be obtained on said invention and/or application;

AND ASSIGNORS HEREBY authorize and request the Patent Office or other issuing authority to issue any and all patents on said invention and/or said application to said ASSIGNEE as sole assignee; and further hereby authorize said ASSIGNEE to file and prosecute any of said foreign applications in its own name;

AND ASSIGNORS HEREBY covenant that they have the full right to convey the entire right, title and interest herein assigned and have not executed and will not execute any assignment or other instrument in conflict herewith;

AND ASSIGNORS HEREBY further covenant and agree to communicate to said ASSIGNEE, or its legal representatives, successors or assigns, any facts relating to said invention, including evidence for interference purposes or other proceedings, whenever requested, and to testify in any interference or in any other legal proceeding, when requested, and to execute and deliver on request all lawful papers required to make any of the foregoing provisions effective; and to perform the aforesaid communicating, executing and delivering, without any payment except expenses and to perform the aforesaid testifying for reasonable compensation; and generally to do everything possible to aid the said ASSIGNEE, its successors, legal representatives or assigns to obtain and enforce proper patent protection on and for said invention in all countries, and likewise make these provisions binding upon our heirs, legal representatives and/or administrators.
