ASSIGNMENT

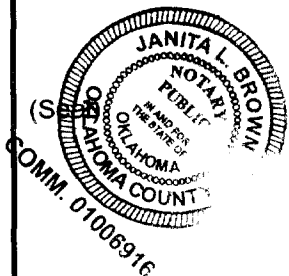
