THIS PATENT RELEASE AND REASSIGNMENT is made as of June /0, 2003, by ANTARES CAPITAL CORPORATION, a Delaware corporation, as Agent ("Agent").

W I T N E S S E T H:

WHEREAS, Agent and Safer, Inc., a Delaware corporation formerly known as New Safer, Inc. ("Safer"), were parties to that certain Patent Security Agreement dated as of July 25, 2001 (the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Safer granted a security interest to Agent in, among other things, the Patents (as defined below) as security for certain obligations owing by Safer to the financial institutions (collectively, the "Lenders") from time to time party to that certain Credit Agreement dated as of December 2, 1999 by and among WS Acquisition Corp., a Pennsylvania corporation, such Lenders, and Agent, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Patents set forth on Exhibit A hereto; and

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Safer's right, title and interest in and to all of the following:

(a) all patents and patent applications, the inventions and improvements described and claimed therein, all patentable inventions, and the reissues, divisions, continuations, renewals, extensions and continuations-in-part of any of the foregoing (all of the foregoing in this clause (a) and any part thereof are referred to herein as the "Patents"), including, without limitation, the Patents listed on Exhibit A annexed hereto;

(b) all Patent licenses, including, without limitation, the Patent licenses listed on Exhibit A annexed hereto;

(c) all products, proceeds, income, royalties, damages and payments now or hereafter due and/or payable under or with respect to any of the foregoing,
