

WHEREAS, I Hiramie T. McAdams, citizen of the United States of America, has invented certain new and useful improvements in **REFORMULATED DIESEL FUEL**, which I am about to file an application for United States Letters Patent identified as DOE Invention Docket No. S- 99,306 executed on 1-25-2003, respectively; and;

We agree to make, execute, and deliver unto the Government of the United States, as represented by the United States Department of Energy, any and all papers, documents, affidavits, renewal, divisional and reissue applications, statements, or other instruments in such usual or other forms, with terms and contents as may be required by the United States Department of Energy, or its duly authorized representative, in or incident to the prosecution or conduct of any and all applications, before as well as after, the issuance of any Letters Patent thereon, or in the adjustment or settlement of any interferences or other actions or proceedings that said applications may encounter or in which they may become involved, and we agree that we will aid the Government of the United States in every way in protecting the invention as may be requested by the United States Department of Energy, except that any expenses arising through extending such assistance will be paid for by proper arrangement with the Government of the United States.
