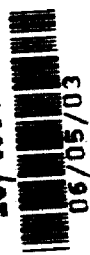

ASSIGNMENT


