And we hereby covenant that we have full right to convey the entire interest herein assigned, and that we have not executed and will not execute any agreement in conflict herewith; and we agree that we will communicate to THE LUBRIZOL CORPORATION all facts known to us respecting said invention whenever requested by it, and will execute all instruments or documents requested by it for the filing and prosecution of applications for Letters Patent of the United States of America and all foreign countries on said invention, or in connection with litigation regarding said invention, or for the purpose of protecting title to said Invention or Letters Patent therefore in the United States or foreign countries and will testify in any legal proceedings relating thereto, at the request of THE LUBRIZOL CORPORATION, all without further or other compensation than that above set forth, but otherwise at the cost of THE LUBRIZOL CORPORATION.

And we further covenant and agree that if and when THE LUBRIZOL CORPORATION desires to file a disclaimer relating to said inventions in the United States or any foreign country, we will, upon its request, sign and deliver all papers requisite for the filing of such disclaimer.

And we authorize and request the Commissioner of Patents and Trademarks of the United States to issue the said Letters Patent to THE LUBRIZOL CORPORATION, as assignee and owner of the said entire interest.
