## ASSIGNMENT AND AGREEMENT





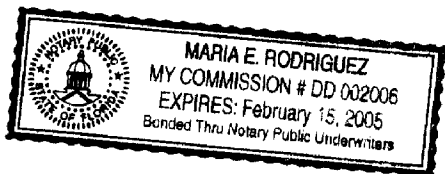
