
as the same would have been held and enjoyed by us, had this assignment, sale and transfer not been made;



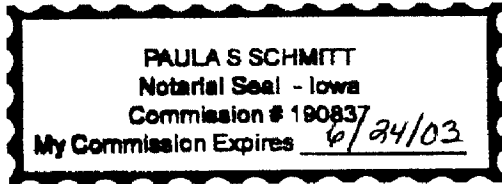

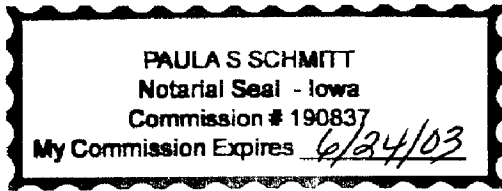
