A S S I G N M E N T

WHEREAS, I Hedi Slimane (hereinafter "the Assignor"), a citizen of France, with an address at 30 Avenue Montaigne, 75008 Paris, France, have invented certain new and useful designs for a GENTLEMAN'S HANDBAG and a GENTLEMAN'S HANDBAG WITH FRONT FLAP for which two applications for United States Design Letters Patent have been executed by me on even date and are based on WIPO Registration No. DM/062 709 filed on January 29, 2003; and


America, and in its territories and possessions and also in all countries foreign to the United States of America, the same to be held and enjoyed by the Assignee for its own use and benefit, and for the use and benefit of its successors, assigns or other legal representatives to the end of the term or terms for which a patent or patents may be granted as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made.

Assignor hereby authorizes and requests the Commissioner For Patents to issue any and all Letters Patent on the aforesaid inventions or resulting from the aforesaid applications directly to the Assignee.

Assignor hereby authorizes the Assignee and its successors to apply for a patent or patents directly in its own name upon the aforesaid inventions wherever the same is permitted by law, and also assigns, sells, transfers and sets over unto the Assignee and its successors all priority rights under the aforesaid applications.

Assignor further covenants to execute all additional instruments and to do all things necessary to carry out the purpose of this instrument, at the expense of the Assignee and its successors.
