WHEREAS, we, Michael BERTHON-JONES and Michael David HALLETT, whose residential addresses are shown below, have made a certain new and useful invention relating to METHOD AND APPARATUS TO COUNTERBALANCE INTRINSIC POSITIVE END EXPIRATORY PRESSURE, which is the subject of an application for Letters Patent in the United States, identified as Application Serial No 09/482,251, filed January 13, 2000 (hereinafter referred to as the "Invention"); and



UPON SAID CONSIDERATION, we hereby covenant and agree with ResMed that we will not execute any writing or do any act whatsoever conflicting with these presents, and that we will, at any time upon request, without further or additional consideration, but at the expense of ResMed, execute such additional assignments and other writings and do such additional acts as ResMed may deem necessary or desirable to perfect ResMed's enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, continuation, continuation-in-part, divisional, renewal, reissued or extended Letters Patent of Australia, or of any and all foreign countries, on said Inventive Subject-matter, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions

involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of both parties.




