Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any official of any foreign country whose duty it is to issue patents to issue any patent claiming any part of the Inventions to Assignee or its successors, assigns or nominees.

Assignor further covenants and agrees that on request and without further consideration, it shall execute and deliver all papers that may be necessary or desirable to perfect the title to the Inventions and Patent Applications in Assignee, its successors, assigns or nominees, execute all divisional, continuing, and reissue applications, make all rightful oaths, and generally assist Assignee, its successors, assigns and nominees to obtain and enforce proper patent protection for the Inventions in the United States and any foreign country.


