Parties

- (1) **ISO DEVELOPMENTS LIMITED** of 44 Mill Road, Northamptonshire NN29 7JA ("the Assignor"); and
- (2) **XYRON UK LIMITED** of 33-37 Bury Old Road, Bolton, Lancashire, BL2 2AY ("the Assignee").

**BACKGROUND**

By a Sale and Purchase Agreement dated 18 December 2001 between the Assignor and the Assignee, the Assignor has agreed to assign to the Assignee all rights title and interest in the patents and patent applications owned by the Vendor including (but not limited to) those listed in the schedule hereto (the "Patents").

**AGREED TERMS**

1. Assignment

In consideration of the payment by the Assignee to the Assignor of £1 (receipt of which is hereby acknowledged by the Assignor), the Assignor hereby assigns to the Assignee all the Assignor's rights, title and interest in and to the Patents, including all rights privileges and advantages attaching to them (including the right to bring proceedings for infringement prior to the date hereof) to hold unto the Assignee absolutely, and to the intent that the Assignee shall (i) be absolutely entitled to any patent granted on any of the patent applications for the full term of such patents; and (ii) have the right to apply for, prosecute and obtain patent or like protection throughout the world for any invention embodied by any of such applications, including the right to claim priority from such applications.

2. Further Assistance

The Assignor shall execute such further documents and do such further things as the Assignee may reasonably request from time to time, at the Assignee's expense, by way of further assurance to confirm to the Assignee all the aforesaid rights in the Patents. Without limiting the generality of the foregoing, the Assignor shall execute and deliver to the Assignee forms of assignment or other documents of transfer in terms reasonably required by the Assignee as soon as reasonably practicable (and in any event within 21 days) following request thereof from the Assignee.

3. Maintenance and Prosecution

- 3.1 The Assignor shall deliver to the Assignee the files which are still in the Assignor's possession at the date hereof relating to each of the Patents.

- 3.2 The Assignor shall undertake all matters relating to the prosecution and maintenance of each of the Patents until the original file relating thereto has been delivered to the Assignee, and in any event for no longer than six months after the date hereof. The Assignor shall not reply to any office action without first consulting the Assignee and obtaining its instructions in relation thereto.
- 3.3 The Assignee shall pay to the Assignor the amount of all fees (including the fees of patent agents) incurred in relation to the prosecution and maintenance of the Patents pursuant to clause 3.2 on a full indemnity basis.
- 3.4 The Assignor shall provide the Assignee with such assistance as it reasonably requires from time to time for the purpose of defending or enforcing any of the Patents, including starting and defending proceedings in the Assignor's name, and provided that the Assignee indemnifies the Assignor for any costs, damages or other liabilities incurred by it as a result.

4. Governing Law

This assignment shall be governed by and construed in accordance with English law.





