The undersigned certify that:

1. They are the duly elected and acting President and Secretary, respectively, of Tempus Fugit, Inc., a California corporation (the "Corporation").
2. Article 1 of the Restated Articles of Incorporation of the Corporation is amended to read as follows:

**"ARTICLE 1**

The name of the Corporation is: Jasper Design Automation, Inc."

3. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the Board of Directors of this Corporation.
4. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of the corporation as follows: 10,148, 654 shares of Common Stock, 3,263,974 shares of Series A Preferred Stock and 7,860,512 shares of Series B Preferred Stock. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was (i) more than 50% of the of the outstanding Common Stock voting as a class, (ii) more than 50% of the outstanding Series A Preferred Stock voting as a class, and (iii) more than 50% of the outstanding Series B Preferred Stock voting as a class.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
