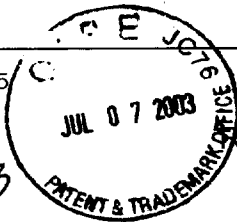

(JOINT)


