

Subject: The application from Acer Display Technology, Inc. to merge with Unipac  
Optoelectronics Corp. and to change the name and the allowed business items of the  
merged company, is allowed and is specified as follows.

20 Explanation:

1. This letter is in reply to the Letter from Acer Display Technology, Inc. which is  
dated 4/27/2001 and with the reference no. 90031.

2. After the merger, Acer Display Technology, Inc., is the surviving company and  
Unipac Optoelectronics Corp., is dissolved. The dissolved company should file  
25 another application to withdraw its registration from the Bureau (Hsinchu  
Science-based Industrial Park Administrative Bureau).

3. The Chinese name of the surviving company 「Acer Display Technology, Inc.」,  
is changed to 「AU Optronics Corp.」 after the merger, and the English name of  
the surviving company 「Acer Display Technology, Inc.」, is changed to 「AU  
30 Optronics Corp.」 after the merger.

4. The allowed business items of AU Optronics Corp., are stated below:

Electronics parts manufacturing (code no. CC01080)

Electronics materials distribution (code no. F119010)

Export products manufacturing (code no. F401030)

Research, develop, manufacture, produce and sell the following products:


1. Plasma display and its system.
  2. Liquid crystal display and its system.
  3. Organic display and its system.
  4. Opto-electric sensing parts made by amorphous Silicon.
  5. Opto-electric sensing parts made by thin film diode.
  6. Opto-electric sensing parts made by thin film transistor.
  7. Contact image sensor.
  8. Active matrix color flat panel display.
  9. Field emission display.
  10. Liquid crystal display made by single crystal silicon.
  11. Manufacturing services for amorphous silicon thin film transistor processes and flat panel display modules.
  12. Manufacturing and design services for flat panel display products.
  13. Trading of the above products and services.
5. AU Optronics Crop. should contact the labor and employer division of the Bureau to file the pollution prevention plan.
6. This merger case should get the approvals from the Securities and Futures Institute (SFI) and the Fair Trade Commission, and then file the merger application and dissolution application separately according to the Corporation Law of the Republic of China.
7. This merger application shall be reviewed and recorded by the Administrative Committee of The Hsinchu Science-based Industrial Park.
