

ASSIGNOR covenant that he has full right to convey the entire interest herein assigned, that he has not executed and will not execute any agreement in conflict herewith, and further covenants and agrees each time request is made and without undue delay, to execute and deliver all such papers as may be necessary or desirable to perfect the sole and exclusive title to said inventions or improvements, said application and said Letters Patent in said ASSIGNEE, its successors, assigns, nominees, or legal representatives, and agrees to communicate to said ASSIGNEE or to its nominee all known facts respecting said inventions or improvements, said application and said Letters Patent, to testify in any legal proceedings, to sign all lawful papers, to execute all disclaimers and divisional, continuing, and reissue applications, to make all rightful oaths, and generally to do everything possible to aid said ASSIGNEE, its successors, assigns, nominees and legal representatives to obtain and enforce for its own benefit proper patent protection for said inventions or improvements in the United States and its possessions and territories and in any or all other countries that ASSIGNEE or its designee shall choose in their exclusive discretion to pursue;

AND ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States and any counterpart in such other countries to issue to said ASSIGNEE, the sole and entire right, title and interest, in and to any and all Letters Patent for said inventions or improvements, including any and all Letters Patent which may be issued and granted on or as a result of the application aforesaid, in accordance with the terms of this assignment.
