

ASSIGNMENT

I authorize and empower said assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or design or other form of protection for said invention or design or for additions and modifications thereto, filed by it or them, the benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it, and to invoke and claim such right of priority without further written or oral authorization from me.

I hereby authorize and request the Commissioner of Patents and Trademarks to issue said Letters Patent and design patent or registration to said
