

KNOW ALL MEN BY THESE PRESENTS:

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to that certain Letter Agreement Re: Purchase of Patent Application and Related Rights, dated as of March 30, 2001 (the "Agreement"), CONTINENTAL STRUCTURES SPRL, ("Seller"), for itself and for its successors and assigns, does hereby grant, convey, transfer, assign and deliver to OMNIGLOW CORPORATION, a Delaware corporation ("Buyer"), its successors and assigns, the following property and assets owned by Seller:

1. One machine prototype, consisting of a pulling device and the following stations, for handling tapes of coated aluminum foil:
 - (a) station for embossing the foil, with adjustable toolings;
 - (b) station for filling;
 - (c) station for heat sealing; and
 - (d) station for cutoff operation, with toolings.
2. One Branson 450 watt, ultra-sonic sealer machine, with various toolings adapted to the "flat light" product.
3. One experimental lacquer coating device.
4. Belgium Patent Application No. 2000/0195, all files relating thereto and all rights associated therewith.
5. PCT Patent Application No. BE01/00040, all files relating thereto and all rights associated therewith.
6. All Know-how (as defined in the Agreement) relating to the foregoing.

Seller covenants that it will execute and deliver such additional instruments of transfer as Buyer reasonably may request in order to more effectively transfer any of the property and assets herein granted, conveyed, transferred, assigned and delivered to Buyer.
