INDUSTRIAL DESIGN AND DESIGN PATENT ASSIGNMENT

WHEREAS, pursuant to the Asset Transfer Agreement dated as of the Effective Date between Assignor and Assignee (the "Asset Purchase Agreement"), Assignor has sold to Assignee, and Assignee has purchased from Assignor, all industrial designs registrations and applications, design patents and applications worldwide of the Assignor in connection with the BRP Business Segment, all re-examinations, reissues, divisions, renewals, extensions, provisionals, continuations and continuations-in-part thereof, including those set forth in Schedule A hereto, and the inventions as fully described and claimed therein, including any and all rights to file international or foreign applications claiming priority to any of the foregoing (the "Industrial Designs");

WHEREAS, pursuant to the Asset Transfer Agreement, Assignor and Assignee wish to enter into this Assignment to confirm the assignment from Assignor to Assignee of all of Assignor's rights to the Industrial Designs; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor assigns to Assignee all rights, title and interests in and to the Industrial Designs, and all Letters Patent, Inventor's Certificates, Utility Models and Registered Industrial Designs which have been or may be granted thereon, together with the right to sue and recover damages for past or future infringements of the Industrial Designs and to fully and entirely stand in the place of Assignor in all matters related thereto.

Assignor hereby requests the Commissioner of Patents or such other corresponding responsible authority (the "Commissioner") to record this Assignment to Assignee. Assignor hereby requests the Commissioner to issue any and all Letters Patent, Inventor's Certificates, Utility Models and Registered Industrial Designs derived from the Industrial Designs to Assignee as assignee of the entire interest.

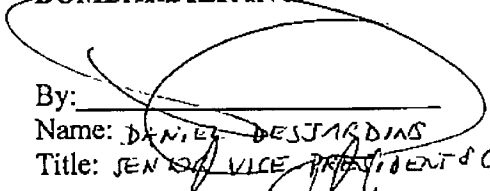
