ASSIGNMENT

Whereas, We, JÖRG GROTENDORST of Lortzingstrasse 2, 30823 Garbsen, Federal Republic of Germany, and LUDWIG DREILICH of Ludwig-Moritz-Strasse 8, 31535 Neustadt, Federal Republic of Germany, have invented certain new and useful improvements in Tire Pressure Control Arrangement for a Motor Vehicle for which application for United States Letters Patent has been executed on even date herewith, (said application having Attorney Docket No. 202-051); and,



lawful acts requisite for the application, for such divisional, continuing or reissue applications or the procuring thereof, and we further covenant and agree that we will, at any time upon request, do everything legally possible to aid said CONTINENTAL, its successors, assigns, nominees or other legal representatives, either in its or their own name, to maintain and enforce any patent for said improvements without further consideration but at the expense of said CONTINENTAL, its successors, assigns, nominees or other legal representatives.



