ASSIGNMENT

WHEREAS, I, Curtiss Renn, of Bend, County of Deschutes, State of Oregon, have invented certain improvements in a METHANOL STEAM REFORMING CATALYSTS, STEAM REFORMERS, AND FUEL CELL SYSTEMS INCORPORATING THE SAME, for which I have executed an application for Letters Patent of the United States on the date I executed this Assignment as hereinafter set forth; and

Further, I agree that I will communicate to the said IDATECH, LLC or its representatives any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all related, divisional, continuation, substitution, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to IDATECH, LLC, make all rightful oaths and generally do everything possible to aid IDATECH, LLC, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and in any and all foreign countries.
